# BACKGROUND: (CONT'D)

Until a successor to Mr. Smithey qualifies, Government Code section 31520.1 provides, in part, that the alternate seventh member shall fill a vacancy in the Member 3 seat. The alternate seventh member seat is held by Reggie Powell.

Nominations for the Member No. 3 seat shall be on forms provided by the County Clerk starting on Monday, May 17, 2021 and filed in that office not later than 5 p.m. on Friday, June 11, 2021. Election Day is fixed as Tuesday, September 7, 2021. Any Ballot reaching the County Clerk's Office after 5 p.m. on Tuesday, September 7, 2021 shall be voided and not counted.

## CONSEQUENCE OF NEGATIVE ACTION:

Inaction would delay in election of the 3rd member of the Contra Costa County Employees' Retirement Association Board.
