Subject: Amendment Agreement #29-203-99 with California Department of Public Health

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Amendment Agreement #29-203-99 (State #19-10143, A02) with California Department of Public Health, to increase the payment limit by \$252,707 from \$13,083,059 to a new total amount payable to the County of \$13,335,766 for the Women, Infants and Children (WIC) Program, with no change in the original term of October 1, 2019 through September 30, 2022.

FISCAL IMPACT:

Approval of this amendment will allow the County to receive additional funding in the amount of \$252,707 for the period October 1, 2020 through September 30, 2022. No County matching funds are required.

BACKGROUND:

Since 1974 the County has participated in the WIC Program with the State. This is a mandated program under the Community Health Services Division of the State Department of Health Services. WIC is a nutrition education, counseling and food supplement program for low-income, pregnant, postpartum and breast-feeding women, infants and children at

On September 17, 2019, the Board of Supervisors approved Standard Agreement #29-203-97 with the California Department of Public Health, in an amount not to exceed \$12,941,349 for the WIC

BACKGROUND: (CONT'D)

Program, for the period from October 1, 2020 through September 30, 2022.

On September 15, 2020, the Board of Supervisors approved Amendment Agreement #29-203-98 with the California Department of Public Health, to increase the payment limit by \$141,710 to a new total of \$13,083,059 for additional WIC services, with no change in the term of October 1, 2020 through September 30, 2022.

Approval of Amendment Agreement #29-203-99 will allow additional funding for the County to continue nutrition assessments and education, community referrals, and food checks to eligible residents of Contra Costa County, through September 30, 2022.

CONSEQUENCE OF NEGATIVE ACTION:

If this amendment is not approved, the County will not receive funds to continue nutrition assessments and education, community referrals, and food checks to eligible residents of Contra Costa County.
