#### **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Public Works Director, or designee, to execute a contract amendment with Zachary Neal Keas (dba Z.N. Keas Painting Co.), effective April 30, 2021, to extend the term from April 30, 2021 through October 31, 2021, to provide on-call painting services, with no change to the payment limit of \$1,500,000, Countywide.

#### **FISCAL IMPACT:**

Contract costs are budgeted in the Facilities Maintenance Budget. There is no fiscal impact to this action.

### **BACKGROUND:**

Facilities Services is responsible for the maintenance of all County site and facilities. On-call painting contracts are on an as-needed basis, utilized when the demand for painting services exceeds staffing levels. The Public Works Department recently conducted a formal solicitation for new on-call painting contracts and is requesting this contract be extended while the department evaluates, awards and executes the new painting contracts.
