Subject: APPROVE and AUTHORIZE Amendment No. 2 to the Contract with Frank McGuire (dba The Landscape

Company), to extend On-Call Landscaping Services.

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Public Works Director, or designee, to execute a contract amendment with Frank McGuire (dba The Landscape Company), effective June 8, 2021, to extend the term from June 30, 2021 through December 31, 2021, to provide on-call landscaping services, with no change to the payment limit of \$2,000,000, Countywide.

FISCAL IMPACT:

Contract costs are budgeted in the Facilities Maintenance Budget. There is no fiscal impact to this action.

BACKGROUND:

Public Works Facilities Services is responsible for maintaining the irrigation and drainage systems at County facilities along with weed abatement of County-owned properties. On-call landscaping contracts are on an as-needed basis, utilized when the demand for landscaping and weed abatement services exceeds staffing levels. The Public Works Department recently conducted a formal solicitation for new on-call landscaping contracts and is requesting this contract be extended while the department evaluates, awards and executes the new landscaping contracts.
