

Subject: Grant Agreement #28-963 with the State of California, Business, Consumer Services and Housing Agency for the Homeless Housing, Assistance, and Prevent

### **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #28-963 with the State of California, Business, Consumer Services and Housing Agency (BCSH) for the Homeless Housing, Assistance, and Prevention (HHAP) Program, to pay the County an amount not to exceed \$2,424,178, for the Health, Housing and Homeless Services Division to provide supportive housing services for homeless individuals and families in Contra Costa County, effective upon BCSH signature through June 30, 2026.

#### **FISCAL IMPACT:**

This grant agreement will result in an amount not to exceed \$2,424,178 in funding from the State of California, BCSH. No County match is required.

### **BACKGROUND:**

On July 31, 2019, Governor Newsom signed into law the HHAP program (Assembly Bill 101, Chapter 159, Statutes of 2019). The HHAP program is a block grant program designed to provide jurisdictions with one-time grant funds to support regional coordination and expand or develop local capacity to address their immediate homelessness challenges
