Subject: Amendment Agreement #23-463-13 with Valerie Gulyash

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Amendment Agreement #23-463-13 with Valerie Gulyash, an individual, to amend Contract #23-463-12, effective January 1, 2022, to increase the payment limit by \$150,000 from \$150,000, to new payment limit of \$300,000, to continue to provide consulting and technical assistance for the Department's Chargemaster billing and EPIC Electronic Medical Record systems used at Contra Costa Regional Medical Center and Contra Costa Health Centers, with no change in the original term of January 1, 2021 through December 31, 2022.

FISCAL IMPACT:

This contract will result in additional contractual service expenditures of \$150,000 over a 2-year period and will be funded 100% by Hospital Enterprise Fund I revenues. (No rate increase)
