Subject: Novation Contract #74-358-12 with Contra Costa Crisis Center

---

**RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Novation Contract #74-358-12 with Contra Costa Crisis Center, a non-profit corporation, in an amount not to exceed \$389,906 to provide Mental Health Services Act (MHSA) Prevention and Early Intervention (PEI) services through a twenty-four hour crisis line for the period from July 1, 2021 through June 30, 2022, which includes a six-month automatic extension through December 31, 2022, in an amount not to exceed \$194,953.

**FISCAL IMPACT:**

Approval of this contract will result in annual expenditures of up to \$389,906 for FY 2021-2022 and will be funded 100% by State MHSA revenues. (Rate increase)

**BACKGROUND:**

This contract meets the social needs of the County's population by providing a nationally-certified 24-hour suicide prevention hotline that lowers the risk of suicide at a time when people are most vulnerable, enhances safety and connectedness for suicidal individuals, and builds a bridge to community resources for at-risk persons. BACKGROUND: (CONT'D)

been providing MHSA PEI services to the County since July 1, 2009.

On December 15, 2020, the Board of Supervisors approved Novation Contract #74 358-11 with Contra Costa Crisis Center in an amount not to exceed \$330,006 to provide MHSA PEI services for the period from July 1, 2020 through June 30, 2021, which included a six-month automatic extension through December 31, 2021, in an amount not to exceed \$165,003.

Approval of Novation Contract #74–358–12 replaces the automatic extension under the prior contract and allows the contractor to continue providing services through June 30, 2022.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, the contractor will not be able to provide suicide prevention hotline services to non-English speaking callers.
