RECOMMENDATION(S):

ACCEPT the presentation from the Employment and Human Services Department on the California Statewide Automated Welfare System (CalSAWS) implementation plan.

FISCAL IMPACT:

This report is informational and there are no fiscal impacts associated with the acceptance of this report.

BACKGROUND:

Referral No. 44 to the Family and Human Services Committee (FHS) was originally made by the Board of Supervisors on April 25, 2000. Another referral to FHS, number 19, on Welfare Reform was referred on January 21, 1997. On January 1, 2005, the Board of Supervisors combined these two referrals so that the Employment and Human Services Department (EHSD) could provide updates on various aspects of their programs as the need arose. Since that time, the FHS has received annual updates from the Employment and Human Services Department on a variety of issues impacting the Department. On June 7, 2016, the Board approved the recommendation of the EHSD Director to eliminate the "Office of the Future" component of the referral and expand the referral to include
