Subject: APPROVE and AUTHORIZE Amendment No. 1 to the Contract with Waters Moving & Storage, Inc.

## **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Public Works Director, or designee, to execute a contract amendment with Waters Moving & Storage, Inc., to extend the term from May 31, 2022 to November 30, 2022, to provide on-call moving, storage and OLP (office landscape partition) services, with no change to the payment limit of \$1,000,000, Countywide.

## **FISCAL IMPACT:**

There is no fiscal impact with this action as the amendment is only to extend the term of the contract.

## **BACKGROUND:**

Public Works utilizes contractors for moving, haul away and storage services, including office landscape partitional furniture (OLP) repair, replacement, and reconfiguration. Government Code Section 25358 authorizes the County to contract for maintenance and upkeep of County facilities. On July 11, 2019, the Board approved a contract with Waters Moving & Storage, Inc., for the term June 11, 2019 through May 31, 2022 in the amount of \$1,000,000.
