## **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #27-966-5 with Bellevue Eye Medical, Inc., a corporation, in an amount not to exceed \$525,000, to provide ophthalmology services for Contra Costa Health Plan (CCHP) members and County recipients, for the period June 1, 2022 through May 31, 2025.

## **FISCAL IMPACT:**

This contract will result in contractual service expenditures of up to \$525,000 over a three-year period and will be funded 100% by CCHP Enterprise Fund II revenues. (No rate increase)

## **BACKGROUND:**

CCHP has an obligation to provide certain ophthalmology services for its members under the terms of their Individual and Group Health Plan membership contracts with the County. This Contractor has been a part of the CCHP Provider Network providing these services
