## BACKGROUND: (CONT'D)

In conjunction with Junior Achievement, the Contra Costa District Attorney's office, and Deer Valley's Law & Justice Academy are offering students at Black Diamond Middle School an opportunity to participate in a Law Enforcement Introduction Program. It is anticipated that 75 seventh graders from the Middle School will participate in a variety of activities around crime scene investigation and mock trial. Activities include a crime scene walk thru, a mini mock trial and an opportunity for career exploration with volunteers from the Contra Costa District Attorney's office. The objective of this program is to generate student interest in the Law & Justice Academy held at the local high school, as well as careers in public service.
