Subject: Rescind Prior Board Action Pertaining to Contracted Services with Granicus, LLC

RECOMMENDATION(S):

RESCIND Board action of November 2, 2021 (C.40) which pertained to a contract with Granicus, LLC; and APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #23-721 with Granicus, LLC, a limited liability company, in an amount not to exceed \$890,850, to develop, support and maintain a new Health Services Department (HSD) website, for the period from June 1, 2022 through May 31, 2025.

FISCAL IMPACT:

Approval of this contract will result in expenditures of up to \$890,850 over a three-year period and is funded by 51% State grant funds (\$450,000) and 49% Hospital Enterprise Fund I (\$440,850).

BACKGROUND:

Granicus, LLC will replace the current cchealth.org website and it's 2,900 subsidiary web pages, content, and functionality. Granicus, LLC was chosen among several vendors for their outstanding work and outcomes with other California Counties and related governmental agencies. This contract will allow the contractor to plan, develop, test, roll-out

and support the County HSD website for a three-year period. The existing County website was coded manually over a period of many years and has become problematic to update and add to. This new website and the functionality provided by the contractor will provide a lower cost of maintenance, easier usability by the County and community members, and give greater control to our community members to get information as requested.

The contract includes a provision limiting Granicus' liability to the County for direct damages to the amount paid by County in the twelve months preceding the claim for damages.

On November 2, 2021, the Board of Supervisors approved C.40 in an amount not to exceed \$890,850, however the term dates were incorrect. This Board Order will rescind that incorrect Board Order and allow the correct terms to be approved. Under Contract #23-721, contractor will develop, support and maintain a new HSD website for the period June 1, 2022 through May 31, 2025.

CONSEQUENCE OF NEGATIVE ACTION:

If the recommendation is not approved, the prior incorrect Board action will stand and the department will not have Board authorization to receive the contractor's services during the

needed term dates.
