### BACKGROUND: (CONT'D)

Medical Record Technician position in order to assist the Medical Record Administrator (MRA) in providing lead direction to staff in the Pittsburg, Antioch and Brentwood Health Centers. Additionally, the incumbent appointed to this position will be assigned to provide coverage in the three health centers in the absence of technicians to ensure timely processing of medical records.

The Department has determined that the two vacant positions are no longer needed - MRT position#7204 has remained vacant since 2000, and CEL position #13975 has never been filled.
