#### **RECOMMENDATION(S):**

Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Novation Contract #74–379–1 with People Who Care Children Association, a non-profit corporation, in an amount not to exceed \$272,242, to provide Mental Health Services Act (MHSA) prevention and early intervention services for the period from July 1, 2010 through June 30, 2011. This Contract includes a six-month automatic extension through December 31, 2011, in an amount not to exceed \$136,121.

#### FISCAL IMPACT:

This Contract is funded 100% by Proposition 63/MHSA. No County funds are required. (No rate increase)

# **BACKGROUND:**

This Contract meets the social needs of County's population by providing work experience for 150 multicultural youth residing in the Pittsburg/Bay Point communities, as well as programs aimed at increasing educational success among youth who are either at-risk or high-risk of dropping out of school, or committing a repeat offense. # BACKGROUND: (CONT'D)

September 15, 2010, the Board of Supervisors approved Novation Contract #74–379 with People Who Care Children Association, for the period from July 1, 2009 through June 30, 2010, which included a six-month automatic extension through December 31, 2010, for the provision of MHSA prevention and early intervention services.

Approval of Novation Contract #74–379–1 replaces the automatic extension under the prior Contract and allows the Contractor to continue providing services through June 30, 2011.

### CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, at-risk youth from East Contra Costa County will not receive prevention and early intervention services under the Mental Health Services Act.
